MEDIA AND SOCIETY

1st Year Module in Three-Year Bachelor's Degree

Course Description: This course takes a critical approach to the study of the role of the media in society. It will take a value-based approach to the production and consumption of mass media, with a special emphasis on the role of media in community building and promoting social harmony. Traditional Asian philosophical approaches to social interaction, governance and stability will be explored and compared with contemporary ideas of the media acting as a democratization tool.

Number of Hours per Week: 1 hour lecture and 3 hour seminar / tutorial.

Tutorial: Research paper presentation.

Grading and Assessments:

Attendance and Class Participation – 10%

Attendance in class – both lectures and tutorials – are not an option. Attendance will be taken during class and students are expected to take part in interactive discussions and class exercised to obtain high grading for this component.

• Mid-Term Group Assignment - 15%

Students will work in groups of 3-4 to plan and present a TV Talkshow style panel discussion of between 20-25 minutes duration. They will be given 4 themes under which to prepare the panel discussion. The themes will be:

- 1) What can the present generation learn from ancient Asian philosophical ideas to improve democracy and good governance?
- 2) Is mass media really a Western concept? If not what were its origins?
- 3) Can ancient Asian wisdom assist to redefine human rights and freedom of speech?
- 4) Can communication theories be de-westernized and how?

In week 4 the lecturer will assign one of the above themes to each group to prepare the presentation to be done during tutorial in week 6. One of the group members will have to play the moderator/program host role. The grading will be based on the presentation and the lecturer will take into account such criteria as the quality of the information reflecting lecture material conveyed during the discussion, the planning of the discussion and the conclusions that it led to.

Essay and Presentation – 25%

This assignment will be done in pairs or groups of 3 (depending on class number). It will be a research report based on literature surveys, lectures and classroom discussions. Some interviews to substantiate literature survey may be permitted, but no location / field research is necessary. In week 7 a research topic in the form of a one-page (maximum 500 words) research proposal will be submitted to the lecturer, who will approve it by the tutorial in week 8. By week 5, the lecturer should have provided written guidelines for this assignment that should indicate the format, methodologies to be used and the length and style of the final report to be submitted by the end of week 11. The research report would be between 2,000-2,500 words and references in APA style. The group will make a 10 minute presentation to class of their research findings during week 12 tutorial. The grading will be based on both the presentation and the research paper submitted.

• Final Exam - 50%

This exam may be either closed or open book and of 3 hours during which the students will have to answer 3 question with 2 to 3 parts to each question. It may

include 1 compulsory question covering a major theme of the course, and 3 to 4 other questions from which only 2 would be answered. (END)
