# **DEVELOPMENT REPORTING**

**Level of Course:** Bachelor Level (Tier 3) Final Year Elective of an undergraduate degree in Journalism or Mass Communication.

**Course Description:** This course is designed to develop specialised reporting skills of a journalism student in reporting issues dealing with various aspects of development. The traditional concept of development itself would be challenged in this course and new ideas examined and explored that are specific to the Asian environment. Traditional Asian wisdom will be considered in the context of developing new paradigms of development reporting. Lecturers are encouraged to source sample story ideas for each week from your own country or the immediate neighbourhood.

Mode: Lectures and tutorials / workshops.

Number of weeks: 12 weeks, 1 semester

Number of hours per week: 3 hours (1 hour lecture + 2 hour tutorial)

# **Course Description:**

#### WEEK 1 LECTURE: NEWS VALUES, NEWS AGENCIES AND GLOBAL MEDIA

This lecturer will give an overview of the construction of news values, function of news agencies and the global flow of news and its role in shaping development news.

**Tutorial**: Divide the class into 5 or 6 groups and allocate a country for each group asking them to write a 250-300 words news report on any aspect of the chosen country for an international news agency. They may be given up to 1 hour to do this exercise and read the report to class after that. Discussion will follow on the news values adopted.

#### WEEK 2 LECTURE: WHAT IS DEVELOPMENT?

An examination of what is meant by "development" and various definition of it – historic and contemporary.

**Tutorial**: Provide a summary via a powerpoint presentation of the main elements with regards to development issues that are discussed in the following 5 listed readings. A photocopy of the apropriate

chapter from each reading will be provided for easier reference. Divide the class into 5 groups and give each group one of the elements and ask them to draft a 5 minute presentation on how a journalist could address this issue with an example given from your own country or region. They may take up to an hour to draft the presentation.

#### WEEK 4 LECTURE: THE CHALLENGE - REPORTING EVENTS VS PROCESSES

This lecture will explore the challenges development journalism faces due to commercialisation and globalisation of the media which makes sensationalism and dramatisation important aspects of news reporting, and why development journalism should be about reporting a process. Reporting of the 2004 Asian Tsunami will be closely examined as a case study.

**Tutorial / Workshop:** Climatic change has put people, the economy and the natural resources of the Greater Mekong Subregion (GMS) at risk. Increased weather variability and extreme weather events are expected to reduce agriculture yields, lessen the availability of fresh water and further degrade biodiversity and ecosystem services. The GMS countries are Cambodia, Laos, Myanmar, Thailand, Vietnam and China's Yunan and Guangxi provinces. This is a process that could produce events of calamity-nature. Taking the following report from the Asian Development Bank (ADB) as a resource and a guide, discuss what type of story ideas could be developed to report on GMS communities that will analyse the process of climatic change, but also aim through the stories to warn people of the dangers involved and provide guidance for cushioning the communities from the ill-effects of this environmental process. The students will be asked to read up on this report before coming to class this week. The report is:

#### WEEK 5 LECTURE: WRITING AND PRODUCING DEVELOPMENT FEATURES

Mainly focused on news features on development issues for the text media, this lecture will examine the skills and techniques necessary for doing good development stories especially in the Asian context.

**Tutorial:** Divide the class into groups and give each group a set of background information on a certain development issues relevant to your area and ask them to draw up an outline of a development journalism feature noting the type of additional research that may be needed, people to be interviewed and the main focus of the story. They may also comment on why they feel that focus is important. They need to complete the exercise in class and present the outline in a presentation within class time.
